1	Post	Assistant Station Master Gr-I (BSP-10)
2	Place of Posting	Anywhere within the jurisdiction of Sukkur Division
3	Period of Contract	One year with effect from the date of assumption/charge duty (not extendable)
4	Pay & Allowances	You will be allowed pay and allowances for the post as admissible under the rules.
5	Seniority	This contract appointment does not confer any right for being placed in gradation/seniority list of the cadre/group to which the subject post belongs.
6	Leave	As admissible under the revised leave rules-1980. However, provision contained in Rules-5, 6, 8, 11, 14, 16, 17, 18, 18-A, 19, 27, 33, 34, 35, 36 & 39 of rules ibid shall not apply all leave at your credit will lapse on termination of this contract.
7	Medical Facilities	As admissible to civil servants of the Federal Government/Pakistan Railways under the rules.
8	Pension	Service rendered under this contract shall not qualify for pension or gratuity.
9	General Provident Fund	No contribution towards GP Fund shall be required.
10	Conduct and Discipline	You will be governed by the Government, Rules and instructions issued by the Government, or a prescribed authority as for Civil Servants under section 15 and 16 of the Civil Servant Act, 1973 as amended from time to time and E&D Rules, 1973 shall apply.

15	Privilege pass for journey by train	You will be entitled free passes as admissible to the post on which you applied.

- This office's appointment will be treated as cancelled if you do not convey acceptance thereof resume duty within the time specified in para 02 above.
- You will be admissible to draw increase in pension or pay (one side) during the contract period as increased announce by the Government.
- Selected candidates will be required prescribed Medical Fitness Examination from Divisional Medical Officer, Sukkur.
- The Competent Authority has the right to reject any application for contract appointment without assigning any reason.
- No TA/DA will be paid to the candidates to will be called for interview, Medical examination and other formalities.
