TERMS AND CONDITIONS OF THE RECRUITMENT.

1. There will be no limitation of Domicile, however the retired Drivers, Dy: Driver & Asstt: Drivers of Multan Division will be given preference.
2. Maximum age limit 63 years up to 20-03-2017.
3. The candidates having 05 years experience to work on Goods, Passenger and Mail/Express trains are eligible for said posts.
4. The candidates will be paid only the basic pay of scale 09 and other allowances admissible under the contract appointment. However, they will not be entitled gratuity and pension.
