

## **JOB OPPORTUNITY**

Applications are invited from the candidates belonging to the civil districts falling within the territorial jurisdiction of Pakistan Railways, Karachi Division, to fill up the following vacancies on Karachi Division.

### **Age limit/Requirements:-**

1. Pakistani National 18-25 Years+05 years General relaxation in upper age limit on closing date.
2. In case of Ex: serviceman, the upper age limit is relax-able to the extent of service rendered by him in the Armed Forces or 15 years in addition to item NO.1 whichever is less.
3. The age of candidates belonging to the scheduled Castes. Buddhist Community. Sindh Rural is relaxed for 3 years in addition to item NO.1 above.
4. The age of Government servants and contract employees who have completed 02 years continuous Government service on the closing date for receipt of application is relaxed for 10 years in addition to item NO.1 above.
5. The age of Sons of deceased Civil Servants who died during service is relaxed for 05 years in addition to item NO.1 above.
6. Only those applicants belonging to District/Districts falling under territorial jurisdiction of Karachi Division are eligible to apply.
7. The only male candidates are eligible.
8. The departmental candidates will submit their application through proper channel.

### **Note:-**

1. Where a candidate is entitled to age relaxation under more than one category specified above, he shall be allowed relaxation in age only in one category.
2. In case of Railway employees Son, the father/Mother of the candidates has to submit an affidavit that none of his children is appointed against the Railway quota other than this child.

### **DOMICILE.**

**SANGHAR** (Application of the candidates of Jalal Mari, Shahdadpur, Lundo, Sharhari will not be entertained as these area fall within Sukkur Division).

**DADU** (Application of the candidates of Rehmani Nagar, Pyaro Goth, Radhan, Mehar, K.N.Shah will not be entertained as these area fall within Sukkur Division).

### **Allocated quota for vacancies is as under:-**

1. 5% quota is fixed for minorities/non Muslims.
2. 20% quota including 2% is fixed for son of Railways and deceased employees.
3. 5% quota is fixed for the Orphans.
4. 10% Ex-Service Man.
5. 60% merit. (10% open merit and rest on regional quota).
6. Regional quota will be applicable.

## TERMS AND CONDITION OF THE RECRUITMENT.

1. Candidates who fulfill all the terms and conditions and found eligible will be called for selection. Only those candidates will be called for interview afterward who will qualify the Skill test.
2. Selected Candidates will be required to pass prescribed Medical examination from Pakistan Railways Hospital only.
3. Candidates who have at any time been convicted of offences involving moral turpitude or persons who have been dismissed by the federal or any provincial Government of Pakistan will be considered in-eligible.
4. Candidate who has married or intends to marry a person who is not National of Pakistan, shall not be eligible for appointment to any service or post under the Government of Pakistan.
5. No previous application, if any will be entertained. Candidates may apply afresh.
6. Number of post can be changed (increase/decrease) without assigning any reason.
7. No relaxation in educational qualification and in the Medical fitness test even in case of Railway employee's Sons will be permitted.
8. Third Division will not be entertained for the post of Pointsman & Muawans.
9. No TA/DA or other expenses will be paid to candidates called for Selection.
10. The competent authority has the right to reject any application/all application without assigning any reasons under the rules.
11. Using internal/external influence for recruitment will render a candidate ineligible and disqualified for any employment in Pakistan Railways.

Attested copies of National Identity Card, Domicile, Character Certificate, Relationship Certificate ( in case son of Railways employee), three passport size photograph, Academic qualification Certificate and also contact Telephone Number must be mentioned on the application.
