AGE LIMIT

1. 18-25 years + 5 years General Age Relaxation in upper age limit on the closing date for receipt of applications i.e. **24-04-2017**.
2. In case of ex. Serviceman, the upper age limit is relaxable to the extent of service rendered by him in the Armed /forces, or two year whichever is less.
3. Where a candidate is entitled to age relaxation under more than one category specified above, he shall be allowed relaxation in age only in one category.

2. Candidates are also required to submit hard copy of the application form duly signed and filled, with supporting documents, copy of CNIC, and two fresh passport size photographs and self addressed duly stamped return envelope directly to **PTS (Pakistan**

Testing Services) through courier on the address mentioned on application form i.e. **Pakistan Testing Services (PTS) Head Quarters, 3rd Floor Adeel Plaza, Fazl-e-Haq Road, Blue Area, Islamabad.**

3. Test fees of Rs.200/-shall be paid in any branch of United Bank Limited on prescribed online deposit slip (Online deposit slip is attached with application form) or demand draft of any Bank payable in Lahore in favour M/S **PTS (Pakistan Testing Services)**. No application will be entertained in case the requisite fee as per instruction is not deposited. PTS's copy of original slip must be attached with hard copy of the application forms.

4. Eligibility of the candidates shall be determined on the basis of applicants' qualification, performance in written test to be conducted by **PTS (Pakistan Testing Services)** and interview within the criteria/policy devised by the department.

5. Last date of submission of applications is 24-04-2017.

6. Incomplete applications or applications carrying incorrect information shall be summarily rejected. Only those candidates who fulfill the laid down criteria are eligible to apply.

7. Roll No. Slips containing the information regarding test center, timings and test date shall separately be dispatched directly to candidates by **PTS (Pakistan Testing Services)** at least one week before the test.
