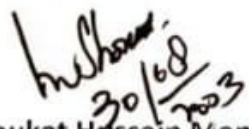
- 1) If the above terms and conditions of contract appointment are acceptable to you, please send your written confirmation on stamp paper worth of Rs. 50/- duly attested by oath commissioner and counter signed by the First Class Magistrate by registered post or personally so as to each to this within due date respectively.
- 2) This office's appointment will be treated as cancelled if you do not convey acceptance thereof resume duty within the time specified in para 02 above.
- 3) You will be admissible to draw increase in pension or pay (one side) during the contract period as increased announce by the Government.
- 4) Selected candidates will be required prescribed Medical Fitness Examination from Divisional Medical Officer, Sukkur.
- 5) The Competent Authority has the right to reject any application for contract appointment without assigning any reason.
- 6) No TA/DA will be paid to the candidates to will be called for interview, Medical examination and other formalities.
