AGE LIMIT

- 18 to 25 Years + 05 years General relaxation in upper age limit upto 05.07.2017.
- In case of Ex. Service man, the upper age limit is relax-able to the extent of service rendered by him in the Armed Forces or 15 Years in addition to item No. 1 whichever is less.
- The age of candidates belonging to the scheduled Castes, Buddhist Community, is relaxed for 3 years in addition to the relaxation mentioned item No. 1 above.
- The age of Government servants and contract employees who have completed 2 years continuous Government service on the closing date of submission of applications is relaxed for 10 years in additional the item No. 1 above.
- In case of sons of deceased Civil Servants who died during service is relaxed for 5 years in addition to the item No. 1 above

TERMS AND CONDITION OF THE RECRUITMENT.

1. All the eligible candidates will be called for Physical Test/Interview for the post of Bridge Muawan, Gateman and Pointsman.
2. The successful candidates in Physical Test will be eligible for interview.
3. **For the category of Assistant Telecom Technician, all eligible candidates will be called for written test and candidates who will qualify the written test will be called for Interview.**
4. Selected candidates will be required to pass Medical Examination prescribed for above categories.
5. Selected candidates for the post of Pointsman & Gateman will undergo prescribed Local Training on Multan Division and for the post of Assistant Telecom Technician will undergo prescribed Training at Pakistan Railways Academy Walton, Lahore.
6. During the training course the trainees will be paid only "Stipend" equivalent to minimum of Basic Pay Scale.
7. Number of posts can be changed at any stage without giving any reason.
8. No relaxation even in case of son of Railway employees in Educational Qualification, age limit (as specified above) and in medical Fitness will be permitted.
9. The Competent Authority has the right to reject any application/applications without giving any reason under the rules.
10. The Competent Authority has the right to cancel the selection if the administrative reasons so warrant at any stage.
11. Women & Disabled Persons are not eligible for above categories of Pointsman, Gatekeeper, Signal Muwan & Gateman.
12. The period of recruitment on contract basis for the category of Gateman & Assistant Telecom Technician will be two years which is extendable for further period of one year subject to satisfactory performance.
13. No TA/DA will be admissible for Physical Test/Interview

SUBMISSION OF APPLICATION

1. The desirous candidates may submit their application on "PLAIN PAPER" free of cost along with complete Curricular Vitae (CV) and required documents. The applications must be deposited by hand or be sent to Divisional Personnel Officer (C.R. Section) Divisional Superintendent, office, Pakistan Railways, Multan by registered Dak up to 05.07.2017. No application will be entertained by hand and by Dak after closing date 05.07.2015.
2. The candidates having higher qualification must link their Matric 2nd Division Certificate with application which is prescribed qualification for the posts of Bridge Muawan, Pointsman & Assistant Telecom Technician otherwise application will not be entertained.

- said quota at the top of the application along with relevant certificates, otherwise their applications will not be entertained in the said quotas.
4. Three (3) postal envelopes and complete postal address written thereon be also sent/linked with applications and names of vacancy should also be mentioned on the corner of envelopes.
 5. The desired post must have to be mentioned on the application bold / clearly and use separate Form/Application/Postal envelopes for each post.
 6. Incomplete applications (without certificates/mark sheets, testimonials and postal envelopes etc) will not be entertained.
 7. Government Servants (including Railway Employees) should submit their applications through the Head of their department by producing **N.O.C** forms their concerned department.
 8. Telephone Numbers, Mobile Numbers should also be endorsed on application from and envelopes.
 9. **NOTE:** The candidates who have already submitted their applications for the posts of Pointsman & Gateman published on 22.03.2017 vide advertisement No. 25 do not need to apply as a fresh. Their previous application will be entertained for recruitment of these categories.
