Applications are invited from the candidates belonging to the Civil Districts falling within the territorial jurisdiction of Pakistan Railways Multan Division, to fill-up the following vacancies on **Contract Basis** over Multan Division.

RECRUITMENT WILL BE CARRIED OUT AS PER FOLLOWING QUOTAS:-

1	Open Merit	60%
2	Sons of Railway Employee either in service, retired or deceased.	20% including 2% quota for sons of those Railway Employee who died on duty
3	Ex. Serviceman.	10%
4	Orphans / Destitute.	05%
5	Minorities.	05%

AGE LIMIT:-

- 18 to 25 years + 05 years General relaxation in upper age limits upto **20-11-2017**.
- In case of Ex. serviceman, the upper age limit is relax-able to the extent of service rendered by him in the Armed Forces or 15 years in addition to item No.01 whichever is less.
- The age of candidates belonging to the scheduled castes, Buddhist communality, is relaxed for 03 years in addition to the relaxation mentioned on item No.01 above.
- The age of Government Servants and contract employees who have completed 02 years continues Government Service on the closing date of submission of applications is relaxed for 10 years in addition to item No.01 above.
- In case of sons of deceased Civil Servants who died during service is relaxed for 05 years in addition to item No.01 above.

DOCUMENTS REQUIRED

Attested copies of :-

- 1) Computerized National Identity Card.
- 2) Domicile.
- 3) Character Certificate (issued by gazetted officer).
- 4) Educational Certificates.
- 5) Relationship Certificate (In case of son of Railways employee).
- 6) Army discharge book (in case of Ex. Service men).
- 7) Three photographs of passport size.

TERMS AND CONDITIONS OF THE RECRUITMENT.

- 1) All the eligible candidates will be called for interview.
- 2) Selected candidates will be required to pass prescribed Medical Examination i.e for Gatemen in Class A-3 without glasses.
- 3) The selected candidates for the post of Asstt. Technician (Telecom) will undergo training at PR Academy Walton, Lahore.
- 4) Selected candidate will undergo for prescribed Local Training on Multan Division.
- 5) During the training course the trainees will be paid only "stipend" equivalent to minimum of basis pay scale.
- 6) Number of posts can be changed without assigning any reasons.
- 7) No relaxation even in case of son of Railway Employees in Educational Qualification, Age Limit (specified above) and in Medical Fitness will be permitted.
- 8) The Competent Authority has the right to reject any application/ applications without assigning any reason under the Rules.
- 9) The Competent Authority has the right to cancel the selection if the administrative reasons so warrant at any stage.
- 10) The recruitment is on contract basis for a period of two (02) years extendable for further period of one (01) year subject to satisfactory performance.
- 11) Women & Disabled Persons are not eligible for above categories.
- 12) No TA/ DA will be admissible.

SUBMISSION OF APPLICATION.


- 1) The desirous candidates may submit their applications on "**PLAIN PAPER**" free of cost alongwith complete Curriculum vita (C.V) and required documents. The applications may also be submitted on forms obtainable from the big station of Multan Division without any application fee. The applications must be deposited by hand or be sent to Divisional Personnel Officer (C. R. Section) Divisional Superintendent, Office, Pakistan Railways, Multan by registered Dak up to **20-11-2017.**
- 2) The candidates having higher qualification must link their Metric 2nd division Certificate with application which is prescribed qualification for the post of Asstt. Technician (Telecom). Otherwise application will not be entertained.
- 3) The candidates who want to apply against the quota of Railways Employee Son, Ex. Servicemen, Orphan/ Destitute or Minority must have to mention the said quota at the top of the application alongwith relevant certificates, otherwise their applications will not be entertained in the said quotas.

- 4) Three (3) postal envelopes with complete address written thereon be also sent/ linked with the applications and names of vacancy should also be mentioned on the corner of envelopes.
- 5) The desire post also must have to mention on the application Bold/ Clearly and use separate forms/ applications / postal envelopes if wish to apply more than one post.
- 6) Incomplete applications (with certificates/ mark sheets, testimonials and postal envelopes) will not be entertained.
- 7) Government Servants (including Railways Employees) should submit their applications through the Head of their Departments by producing **NOC** from their concerned departments.
- 8) Mobile Numbers should also be endorsed on application forms and envelope.
