**AGE LIMIT.**

1. **18 To 25 years + 05 years** general relaxation in upper age limit.
2. In case Ex-Serviceman the upper age limit is relax-able for **15** years or the number of years actually served in the Armed Forces of Pakistan in addition to item No.01 whichever is less.
3. The age of candidates belonging to the Scheduled Castes, Buddhist Community, recognized tribes of the Tribal Areas, Azad Kashmir and Northern Areas for all posts under the Federal Government age shall be relaxed for **03** years in relaxation to item No.01 above.
4. The age of Government servants and contract employees who have completed **02** years continuous Government service on the closing date for receipt of applications is relaxed for **10** years up to the age of **55** years in addition to item No-01 above.
5. In case of sons / daughters of deceased Civil Servants who died during service is relaxed for **05** years in addition to item No.01 above.


**INSTRUCTIONS / TERMS AND CONDITIONS OF THE RECRUITMENT.**

1. The vacancies can be increased / decreased and the recruitment process can be terminated at any stage by the Competent Authorities, without assigning any reasons.
2. In case of Railway employee son / daughter an affidavit that no other child has availed this facility is to be submitted by the Father of the candidate.
3. Government servant including Railway employees should submit applications through their respective departments / proper channel by producing **N.O.C.**
4. Only those candidates who full fill all the conditions will be called for written test / interview.
5. Application must be accompanied with the testimonials. No previous applications will be entertained.

6. No relaxation even in case of son of Railway employee in Education qualification, age limit (specified above) and in Medical fitness will be permitted.
7. The selected candidates will be required to pass prescribed Medical examination from Railway Hospital, Peshawar only.
8. The applications should be written on plain paper (Clearly indicate the name of vacancy) which must reach to this office up to **10-02-2018**, and send through registered Dak on the address:- **Office the Divisional Superintendent, (C.R Section), Pakistan Railways, Peshawar Cantt.**
9. Telephone / Mobile Numbers should also be endorsed on application form and envelopes.
10. In complete applications (without certificates / Degrees, mark sheets, testimonials and postal envelopes) and late received applications after due date will not be considered / entertained.
11. BY hand applications will not be acceptable / entertained.
12. Woman and disable are not allowed for the above post.
13. No TA / DA or other expenses will be given to the candidates called for written test / interview or medical.
