AGE LIMIT

1. The candidates must be in the age bracket of 18-25 Years, where in 05 Years General relaxation is given.
2. (a) In case of Ex: Service Man, the upper age limit relax able to the extent of service rendered by him in the Armed Forces, or 15 years whichever is less.
- (b) The age of candidates belonging to the scheduled casts Buddhist community is relaxed by 03 years in addition to item No. 1 above.
- (c) The age of Government Servants and Contract employees who have completed 02 years continuous government service on the closing date for receipt of applications is relaxed for 10 years in addition to item No. 1 above.
- (d) The age of Son of deceased civil servant who died during service is relaxed for 05 years in addition to item No. 1 above.

SUBMISSION OF APPLICATION & DOCUMENTS REQUIRED

1. Complete typed application with all relevant documents must be sent through “REGISTERED POST” and addressed to the “DIVISIONAL SUPERINTENDENT, PAKISTAN RAILWAYS, LAHORE, DIVISIONAL BOGY ROAD, LAHORE” so as to reach this office latest by **22 October 2018**. Category and quota in which applicant wants to apply should be mentioned on top of the application and on the envelop. After the closing date, no application will be entertained.


The following documents must be attached with the typed application:

- I) Verified Photocopies of Educational Qualification Certificate.
(In case of Middle, Head of Institute/School must verify it and in case of Matric/FA, attested Degree will be required)
 - II) Attested Photocopy of National Identity Card.
 - III) Attested Photocopy of Domicile
 - IV) Attested Photocopy of Character Certificate.
 - V) Attested 3 Pass Port size Photographs (2 must be attested at the back & 1 at the front).
 - VI) Relationship Certificate & Railway Card (in case of Son of Railway Employee).
 - VII) 3 Postal Envelops with complete Home Address, Phone No. & Category/Quota
2. One envelop may contain only 1 application. On the envelop, mobile Number/Phone Number, complete home address and category to be applied must be mentioned.
No application will be received by hand. The envelop must bear the stamp of post office/courier delivery office.

TERMS & CONDITIONS

- a) Only short listed candidates will be called for Skill test and Interview after the scrutiny of educational certificates. Except S No. 5, 9, 10, 11, 12 & 13 will be short listed after written Test for interview as per policy.
- b) No previous application, if any, will be entertained.
- c) Serving Government Servants including Railway Employees should submit their applications through proper channel by providing NOC from their concerned department.
- d) No travelling allowance or other expenses will be paid to the candidates called for Skill test/Written Test and Interview. The successful candidates are required to pass the prescribed Medical test and prescribed training (if any).
- e) Two applications, if present in 1 envelope, will be rejected.
- f) The applications not bearing the stamp of post office/ courier delivery service will be rejected.
- g) Any application addressed to other than Divisional Superintendent Office Lahore will not be entertained.
- h) In complete applications will not be entertained.
- i) A candidate who has married or entered in to the contract of married with the person who is not a citizen of Pakistan may at the discretion of the Government be rendered ineligible for appointment to the post.
- j) The competent authority has the right to reject any application/ all application without assigning any reason under the rules. The competent authority may increase/ decrease the vacancies according to requirement.
