AGE limit

- i. Pakistani National 18 to 25 years + 05 (Five years) General age relaxation in upper age limit on - **03.11.2018**.
- ii. In case of Ex.Servicemen, the upper age limit is relax-able to the extent of service rendered by him in the Armed Forces or 15 years in addition to item No.1 above, whichever is less.
- iii. The age of candidates belonging to the scheduled Castes, Buddhist Community, Sindh Rural Areas is relaxed for 03 years in addition to item No.1,above.
- iv. Age limit is relaxable upto 3 years for the Candidates belonging to Sindh (Rural) for the posts in BPS -15 and below.
- v. Government servants and contract employees who have completed 2 years continuous Government service on the closing date of receipt of application age limit is relaxable 10 years in addition to item No.1,above.
- vi. The Age of disabled candidates is relaxed by 10 years in the permissible categories.
- vii. The age of widow or child of deceased Civil Servant who has died during service is relaxed by 05 years in addition to item No.1,above.
- viii. Where a candidate is entitled to age relaxation under more than one category specified above, he shall be allowed relaxation in age only in one category.

10% quota for women (Where applicable).

20% quota for Son/Daughter of Railway employee including 2% fixed for son /daughter of Railway deceased employee.

DOCUMENTS REQUIRED.

- ❖ Attested copies of educational certificates with Marks sheets.
- ❖ Attested copies of Computerized National Identity Card.(Three copies)
- ❖ Attested copy of Domicile Certificate/PRC.
- ❖ Character Certificate in original.
- ❖ Attested copies of Relation Ship Certificate / Service Certificate in case of Railway employee's Sons/daughters.
- ❖ Disable persons should produce disability certificate from the Department of rehabilitation.
- ❖ Candidates who applied against the quota of orphan/destitute should produce relevant documents with application
- ❖ Three recent passport size photographs should be enclosed with application.
- ❖ Telephone numbers, Mobile numbers should be endorsed on the applications/envelopes.
- ❖ In case of ex: serviceman, discharged certificate from the military department showing service rendered by them has to produce.


INSTRUCTIONS/TERMS AND CONDITIONS OF THE RECRUITMENT.

1. Applicants, can apply for more than one post, but submit separate application alongwith supporting documents.
2. Only those candidates who fulfill all the conditions/submitted complete required documents and applications will be called for skill/written test. Only those candidates will be called afterward for interview who will qualify the skill/written test.
3. In case of Children of Railway employees, the father /mother of the candidate has to submit an affidavit that no one of his children has been appointed against Railway employees quota previously.
4. The selected candidates will be required to pass prescribed Medical examination from Pakistan Railways Hospital only.
5. Candidates who have at any time been convicted of offences involving moral turpitude who have been dismissed by the Central or any provincial Government of Pakistan will be considered in-eligible for recruitment.
6. Candidate who has married or intends to marry a person who is not National of Pakistan, shall not be eligible for appointment to any service or post under the Government of Pakistan.
7. Government including Railway Servants should submit applications through their respective department /proper channel.
8. No previous application, if any will be entertained. Candidates may apply afresh.
9. No relaxation in educational qualification and in the Medical fitness test even in case of Railway employee's sons will be permitted.
10. Third Division will not be entertained where required qualification is Matric and above.
11. The regional quota where applicable will be followed.
12. No TA/ DA or other expenses will be paid to candidates called for written test / interview / Physical /Medical examination.
13. Women are eligible to apply against the post mentioned at item No.1, 2, 3 & 5 above.
14. Disabled persons are eligible to apply against the post mentioned at item No.8,10,11,12,13,15, 16 & 17 subject to production of disability certificate from the department of rehabilitation.
15. Using internal/external influence for recruitment will render a candidate ineligible and disqualified for any employment in Pakistan Railways.
16. Number of posts can be reduced/increased due to administrative reasons.
17. The competent authority has the right to reject any application/ all applications without assigning any reason under the rules.
