Terms and Conditions of the recruitment.

1. There will be no limitation of Domicile, however, the Retired Drivers of Multan Division will be given preference.
2. Maximum age limit is 62 years upto **05-10-2019**.
3. The candidates having 5 years experience to have worked as Driver (BS-14) on Goods, Passenger and Mail/Express trains are eligible for said posts.
4. The candidates will be paid only the basic pay of scale 14 and other allowances admissible under the contract appointment. However, they will not be entitled gratuity and pension.
5. The candidates compulsory retired, removed or dismissed will not be eligible for the said post.
6. The competent Authority has the right to reject any application without assigning any reason under the rules.
7. The call letters for interview to be conducted by the Selection Committee will be issued to only those candidates who are eligible to fulfill the selection criteria.
8. Selected candidates will be required to pass medical examination from Pakistan Railways Hospital (A-One).
9. Selected candidates will be bound to work on Goods, Passenger and Mail/Express trains and can be utilized as per requirement.
10. Selected candidates will have to undergo training in course R-9 before their engagement as Driver from Pakistan Railway Academy Walton, Lahore.
