



NOTIFICATION

No. 15/06-Med/2021-A-II- Dr. Noman Shafi, a BS-18 officer of Medical Department of Pakistan Railways, while working as Senior Medical Officer, (BS-18), Pakistan Railways Cairns Hospital, Lahore was served with a charge sheet dated 11-06-2020 under Government Servants (Efficiency & Discipline) Rules, 1973 for misconduct, inefficiency and unauthorized absence from duty with effect from 11-03-2020. Dr. Shahida Bashir, the then Dy. Chief Medical Officer, Islamabad was nominated as inquiry officer to conduct the proceedings of inquiry into the charges contained in the statement of allegations. On the basis of recommendations of Inquiry Officer, General Manager/W&SI (Authorized Officer) issued Show Cause Notice to Dr. Noman Shafi on 29-10-2020. To defend himself, the accused officer was granted opportunity of personal hearing by the Secretary/Chairman Railways (Authority), but the accused doctor has failed to attend the personal hearing.

After going through facts of the case, available record, recommendations of Inquiry Officer and Authorized Officer, the Secretary/Chairman Railways (Authority) is pleased to impose a Major Penalty of "Discontinuation from Service" upon Dr. Noman Shafi, in terms of Rule 5(1)(iv) read with Rule 10(1)(iv) of Government Servants (Efficiency and Discipline) Rules, 1973 with immediate effect. His intervening period of unauthorized absence w.e.f. 11-03-2020 to 20-10-2021 is treated as Extra-Ordinary Leave (leave without pay).

Dr. Noman Shafi within thirty (30) days from the communication of this order can prefer an appeal to the Prime Minister (Appellate Authority) against the above penalty.
