



**NOTIFICATION**

No.15/6-Med/2018-A-II. Dr. Fatima Kaleem a BS-17 officer of Medical Department of Pakistan Railways, while working as Medical Officer, Pakistan Railways Hospital, Rawalpindi was served with charge sheet in February, 2017 under Government Servants (Efficiency & Discipline) Rules, 1973 for gross misconduct and negligence in connection with unauthorized absence from duty with effect from 25-04-2008. Dr. Aslam Sandeelo, the then Dy.CMO was appointed as enquiry officer to probe the matter, on his retirement from government service on 06-04-2017 on attaining the age of superannuation he was substituted by Dr. Shahida Bashir, Dy.CMO as enquiry officer. On the basis of Enquiry Report, Show Cause Notice was issued to Dr. Fatima Kaleem on 01-03-2018. Since no reply was received to the Show Cause Notice, therefore, a notice was published in the Daily Newspapers on 06-06-2018 but no response was received from the accused officer.

2. After consideration of the available record, recommendations of the inquiry officer as well as recommendation of authorized officer and after granting of opportunity of personal hearing the competent authority, (Secretary/Chairman Railways) has been pleased to decide the case on ex-parte basis and imposed a Major Penalty of "**Dismissal from Service**" upon Dr. Fatima Kaleem, in terms of Rule 5 (iv) of Government Servants (Efficiency and Discipline) Rules, 1973 w.e.f.25-04-2008 i.e. the date of absent from duty.

3. Dr. Fatima Kaleem within thirty (30) days from the communication of this order can prefer an appeal to the Prime Minister (appellate authority) against the above penalty.
